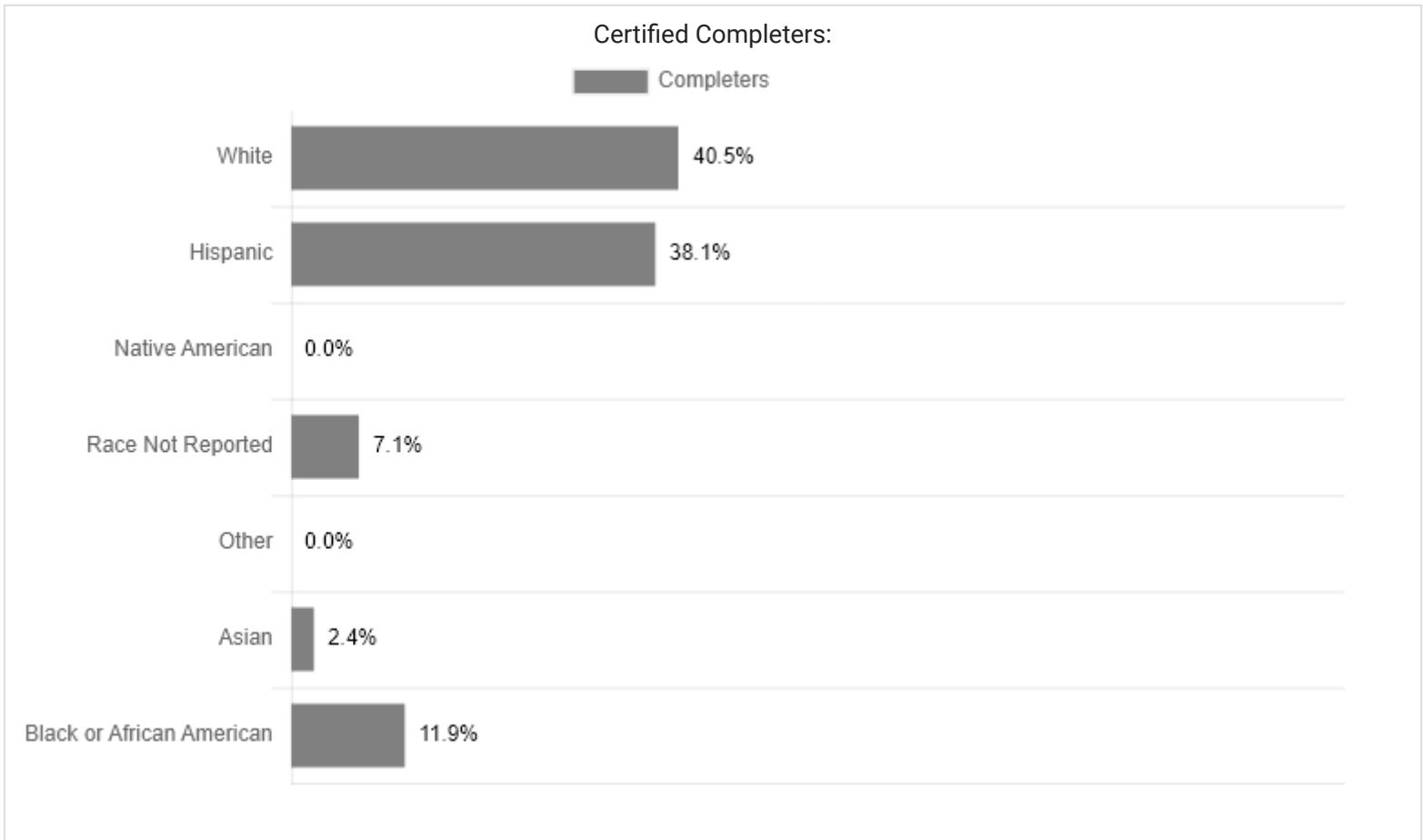

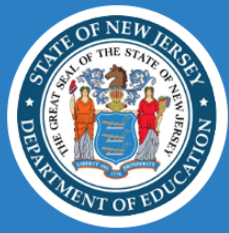

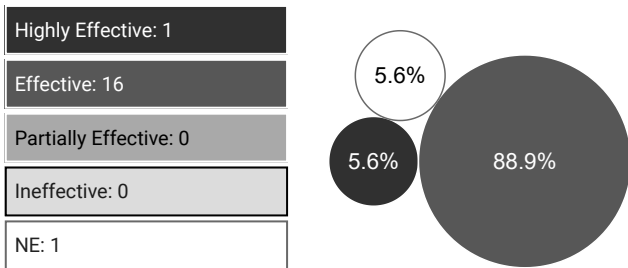
## Evaluation Results

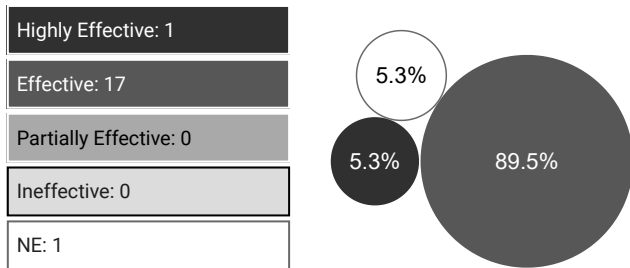
### Summative Score

Summative scores are based on multiple measures of student achievement and teacher practice. While all teachers receive an annual summative evaluation, the components used to determine the summative score vary depending on the grades and subjects that educators teach.



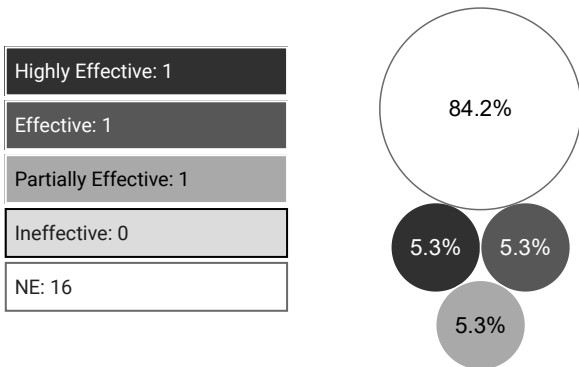
### Teacher Practice Score

Practice is measured by performance on a teacher practice instrument, which is used to gather evidence primarily through classroom observations and pre/post-conferences. Districts have the flexibility to choose from a growing list of state-approved instruments.



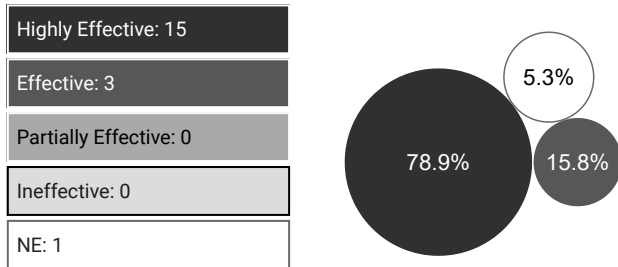
### Teacher SGP Score

Median Student Growth Percentile (mSGP) scores are one of the multiple measures of student achievement for qualifying teachers of 4th-8th-grade Language Arts and 4th-7th-grade Math.



### Teacher SGO Score

The combined score for a teacher's Student Growth Objectives as assessed by the district's evaluation system for assigning teacher or principal performance ratings.

## Glossary:

Term	Definition
<b>Accreditation</b>	Teacher preparation programs are accredited at least every 7 years. An institution that has a professional education unit and has completed successfully a review process by a national professional organization recognized by the Council on Higher Education Accreditation or approved by the Commissioner. The institution must meet State, professional, and institutional standards as determined by a review of its individual programs and overall capacity to prepare education professionals.
<b>CEAS Educator Preparation Program</b>	A program provided by an accredited higher education institution. This program primarily occurs prior to a candidate actively working under a provisional certificate.
<b>Certificate of Eligibility with Advanced Standing (CEAS)</b>	A certificate with lifetime validity issued to persons who have completed degree, academic study, applicable test requirements, and CEAS educator preparation programs for certification. The CEAS permits the applicant to seek and accept employment in positions requiring certification.
<b>Data Collection and Reporting</b>	<p>The New Jersey Department of Education (NJDOE) collects and aggregates the data used for this report from multiple sources. Suppression rules have been applied for the assessment, compensation, and evaluation data included in this report to prevent the identification of individuals and the disclosure of their personal information. The NJDOE collects:</p> <ul style="list-style-type: none"> <li>• <b>Certification</b> data from EPPs and individuals through the Teacher Certification Information System (TCIS), which contains all information regarding the certification status of teachers who have applied for and/or hold a New Jersey certification.</li> <li>• <b>Employment and Compensation</b> data from school districts through the staff-level Standards Measurement and Resource for Teaching (NJSMArt) data system.</li> <li>• <b>Higher Education</b> data from the Office of the Secretary of Higher Education's (OSHE) Student Unit Record (NJSURE) system. OSHE collects data from Institutions of Higher Education (IHE's), but not all IHEs are required to submit data to the NJSURE database. Non-submitting institutions have been noted in the report.</li> <li>• <b>Program level</b> data from EPPs through the teacher preparation program approval process.</li> <li>• <b>School level category</b> data is calculated using growth and proficiency data. This data includes student assessment data, graduation rates, and student growth over time.</li> <li>• <b>Student level demographic</b> data from school districts through the student student-level Standards Measurement and Resource for Teaching (NJSMArt) data system.</li> </ul>
<b>edTPA</b>	Educative Teacher Performance Assessment (edTPA) is the Commissioner-approved assessment measuring a candidate's ability to prepare a lesson, deliver instruction, and assess student learning.
<b>Evaluation: Annual Summative Evaluation Rating</b>	An annual evaluation rating that is based on appraisals of educator practice and student performance, and includes all measures captured in a teaching staff members evaluation rubric. The four summative performance categories are highly effective, effective, partially effective, and ineffective.
<b>Evaluation: Student Growth Objective (SGO)</b>	An academic goal that teachers and designated supervisors set for groups of students.
<b>Evaluation: Student Growth Percentile (SGP)</b>	A specific metric for measuring individual student progress on Statewide assessments by tracking how much a students test scores have changed relative to other students Statewide with similar scores in previous years.
<b>Evaluation: Teacher Practice Score</b>	Performance on a state-approved teacher practice instrument (e.g., Danielson, Marzano, et al.), which is used to gather evidence primarily through classroom observations.
<b>Evaluation</b>	A combination of scores (Student Growth Percentile (mSGP), teacher practice, and student growth objective) that provide a look into teacher effectiveness.
<b>Expired Assessments</b>	When the State Board of Education adopts a resolution to replace a required PRAXIS II test, the replaced test becomes expired. In cases where an individual earns a passing score on the previously required test.

<b>Financial Aid</b>	<ul style="list-style-type: none"> <li>• <b>TEACH Grant</b> – The Teacher Education Assistance for College and Higher Education program provides grants to students who agree to teach for four years at an elementary, secondary, or educational service agency that serves students from low-income families.</li> <li>• <b>AmeriCorps</b> – A national network of national service programs, made up of three primary programs that each take a different approach to improving lives and fostering civic engagement. Members commit their time to address critical community needs like increasing academic achievement, mentoring youth, fighting poverty, sustaining national parks, preparing for disasters, and more.</li> <li>• <b>Federal Title IV Financial Aid</b> – Title IV is a term that refers to federal financial aid funds.</li> <li>• <b>NJ Class Loans</b> – The Higher Education Student Assistance Authority offers the NJ Class Family Loan for Higher Education to help students pay for college costs not already covered by other sources.</li> <li>• <b>Federal PELL Grant</b> – The federal Pell Grant Program provides need-based grants to low-income undergraduate and certain post baccalaureate students to promote access to post secondary education.</li> <li>• <b>Federal Perkins</b> – A Federal Perkins Loan is a low-interest loan for both undergraduate and graduate students in need that helps students finance the costs of postsecondary education.</li> <li>• <b>Federal Direct</b> – Formerly known as Stafford Loans, the William D. Ford Federal Direct Subsidized and Unsubsidized Loans are available to help pay for educational expenses.</li> <li>• <b>NJ Tuition Aid Grant (TAG)</b> – This is a need-based grant awarded to NJ residents. The award amount varies depending on financial need, cost of attendance, and available funding.</li> <li>• <b>NJ Educational Opportunity Fund</b> – The Educational Opportunity Fund provides financial assistance and support services to students from educationally and economically disadvantaged backgrounds who attend institutions of higher education in the State of NJ.</li> <li>• <b>Federal Work-Study</b> – Federal Work-Study provides part-time jobs for undergraduate and graduate students with financial need, allowing them to earn money to help pay education expenses. The program encourages community service work and work related to the student's course of study.</li> <li>• <b>NJ STARS</b> – NJ Student Tuition Assistance Reward Scholarship. This initiative exclusively provides NJ's highest achieving students with free tuition at their home community colleges.</li> <li>• <b>NJ STARS II</b> – NJ STARS students who earn their associate's degrees with a 3.25 grade point average or better are eligible for an annual NJ STARS II scholarship at any NJ public or independent NJ TAG-participating four-year college or university.</li> <li>• <b>World Trade Center</b> – The WTC scholarship benefits dependent children and surviving spouses of NJ residents who were killed or died as a result of injuries sustained by the terrorist attacks against the U.S. on September 11, 2001. The award also benefits the dependents of those who died as a result of illness caused by exposure to the attack sites.</li> <li>• <b>NJ Survivor Tuition Benefits</b> – Survivor Tuition Benefits Program (STB) helps eligible children and spouses of NJ firefighters, emergency service workers, and law enforcement officers killed in the line of duty to earn a bachelor's degree.</li> <li>• <b>Law Enforcement Memorial Scholarship</b> – The Law Enforcement Officer Memorial (LEOM) Scholarship benefits dependent children of NJ law enforcement officers killed in the line of duty.</li> <li>• <b>NJ Governor's Urban Scholarship Program</b> – The Governor's Urban Scholarship Program is a merit-based scholarship program that benefits students in NJ's economically-challenged communities. Recipients must rank within the top 5% of their class and have a cumulative grade point average of 3.0 or higher, plus be a permanent resident of one of the designated NJ communities who will enroll in an approved NJ college, university, or degree-granting proprietary school.</li> <li>• <b>NJ Governor's Industry</b> – The Governor's Industry Vocations Scholarship (NJ-GIVS) pays up to \$2,000 and year or up to the cost of tuition, less any federal, State, or institutional aid in an eligible certificate or degree program at one of NJ's eligible institutions. The scholarship is funded by the Schools Development Authority (SDA) and administered in partnership with the Higher Education Student Assistance Authority (HESAA) to benefit women and minority students pursuing a certificate or degree in a construction-related field.</li> </ul>	
	<b>Partnership</b>	A formal or informal agreement with a school or district in New Jersey in which candidates may complete program requirements.
	<b>Praxis II</b>	Subject-specific assessments that measure a teaching candidate's content knowledge for the endorsement(s) sought.
	<b>Program Completer</b>	Individuals who have successfully completed an approved teacher preparation program to earn certification in New Jersey.
	<b>Program Provider</b>	The hosting organization for an educator preparation program.
